05. The application shall be reached the Chairman, Procurement Committee, Department of Government Factory, Kolonnawa on or before **29/12/2023 at 15.00hrs.**
06. Following registrations shall be required. Attached certified copies to each application.

 - ❖ Certificates for VAT activeness or Non VAT registration from the Department of Inland Revenue
 - ❖ Relevant ICTAD/CIDA registration certificate for work contracts is required for item No. 14 of the service category.
07. Power of Attorney shall be attached to each application, when the Business Entity is a partnership.
08. Credit facilities should be offered at least for one month period.
09. The Government Factory reserves the right to accept/reject any application.
